



## Available for Degree Programs:

Cash Payments through a monthly payment plan or full tuition at the beginning of each term. Signed auto-deduction form in student file.  
 Bottega accepts checks, credit cards (including American Express), debit cards, and third-party financing.

## Available for Full Stack Development Certificate:

The student must be 100% complete with Coding Foundations and have submitted the Capstone for Coding Foundations before the financing and EA occur.

### Apprenticeships:

### Ascent:

**Deferred Repayment** - The student makes no payments while matriculating through the program and for 90 days after completion. Repayment begins at 90 days after completion of the program.

**Interest Only** - While in the program, the student makes low interest-only payments and for 90 days after completion of the program. Repayment begins at 90 days after completion of the program.

**Immediate Repayment** - The student begins repaying the loan one month after beginning the program and continues throughout the program.

Full-time students who are approved for Ascent may receive a living stipend up to \$4,000.

*(Credit score of 620 or higher needed for Ascent.)*

### ISA:

The ISA is a financing option that may be offered to individual students if they present proof they are not able to qualify for traditional loans by a decline decision from two different lenders. Plus, the student must be 100% complete with the Coding Foundations and pay a \$500 deposit. Decision will be made by the Financial Services Support Committee.

Important: Students are encouraged to consult a financial advisor or secure their own financing to discover the best possible interest rate available based on individual credit. The ISA will begin repayment when either of the two following options happen:

- 1.) Students are working in the tech industry making \$40k a year or more.
- 2.) Students complete the program.

The student's payment is 10% of income over three years of repayment.
